

Iowa CE Compliance Guide For LCSWs, LMSWs, LISWs, LMHCs, & LMFTs

lowa-licensed mental health providers are required to complete continuing education (CE) every renewal cycle to maintain their licensure and stay current in best practices. To support our providers in lowa, Psych Hub has put together an overview of lowa's CE requirements for social workers, mental health counselors, and marriage and family therapists, along with curated Psych Hub course recommendations to support those requirements.

IOWA CONTINUING EDUCATION REQUIREMENTS

Social Workers (LBSW, LMSW, LISW)

- 27 CE hours every two (2) years
- Three (3) hours in ethics
- Three (3) hours in supervision (only required if supervising)
- Iowa allows providers to complete CE requirements online, with no limits on the number of hours earned through virtual or self-paced learning.
- First-time licensees are exempt from their initial renewal

Mental Health Counselors & Marriage and Family Therapists

- 40 CE hours every 25-month biennium
- Three (3) hours in ethics
- Three (3) in supervision (for managers and supervisors)
- Iowa allows providers to complete CE requirements online, with no limits on the number of hours earned through virtual or self-paced learning.
- First-time licensees are exempt from their initial renewal

Important Note: Mandatory Reporter Training

lowa requires mandatory reporter training through lowa's Health and Human Services (HHS) program. External training via Psych Hub courses cannot replace this required training. However, Psych Hub offers multiple CE courses that



strengthen the clinical knowledge and skills foundational to safe, trauma-informed care.

Completing any of the courses above can help you meet Iowa's three (3) hour requirement.

Suicide Prevention, Safety Planning, and Crisis Care

While not a state requirement, many lowa clinicians choose to strengthen their skills in suicide risk assessment and crisis response. Psych Hub offers several evidence-informed courses with CE credit, including:

- Safety Planning
- Cognitive Behavioral Therapy for Reducing Suicide Risk
- Counseling on Access to Lethal Means (CALM)
- Foundations in the Safety Planning Intervention for Clinicians
